TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS**, dated as of March 10, 2021 (“Release”), is made by BMO Harris Bank N.A., as administrative agent (“Agent”), in favor of AllOver Media, LLC, a Delaware limited liability company (“Debtor”).

WHEREAS, pursuant to that certain Security Agreement dated as of March 16, 2015 (as amended, modified or restated from time to time, the “Security Agreement”) by and among the Debtor, Agent, and others party thereto and the Patent Collateral Agreement dated as of March 16, 2015 (“Patent Collateral Agreement”) by and among the Debtor and Agent, Debtor granted to the Agent, for the benefit of the Secured Creditors, a continuing security interest in and to all right, title and interest of Debtor in, to and under the Patent Collateral; and

WHEREAS, the Patent Collateral Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on March 19, 2015 at Reel 035225 Frame 0559.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent, on behalf of the Secured Creditors, and Debtor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Patent Collateral Agreement.

SECTION 2. Termination and Release. Agent, on behalf of the Secured Creditors, hereby:

(a) terminates the Patent Collateral Agreement;

(b) terminates, cancels, forever discharges, and releases the continuing security interest in and to all right, title and interest of Debtor in, to and under the Patent Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto;

(c) represents and warrants that it has full authority to execute and deliver this Release; and

(d) authorizes the recordation of this Release by Debtor or any of its designees with the USPTO at Debtor’s expense.

SECTION 3. Further Assurances. Agent, at Debtor’s expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Patent Collateral, Agent will, at Debtor’s expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.

IN WITNESS WHEREOF, the Agent, on behalf of the Secured Creditors, has caused this Termination and Release of Security Interest in Patents to be duly executed as of the date first set forth above.
