Assignor agrees that, upon Assignee's reasonable request and without further consideration but at Assignee's expense, Assignor shall furnish all necessary documentation relating to or supporting chain of title, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for vesting title to the Transferred Patents in Assignee, its successors, assigns and legal representatives or nominees; including but not limited to any acts which may be necessary, desirable or convenient for claiming said rights and for securing and maintaining the Transferred Patents in any and all countries and for vesting title thereto in Assignee and its respective successors, assigns and legal representatives or nominees.

Assignor hereby consents that a copy of this assignment shall be deemed a full legal and formal equivalent of any document which may be required in any country in proof of the right of Assignee to apply for patent or other form of protection for said inventions and to claim the aforesaid benefit of the right of priority.





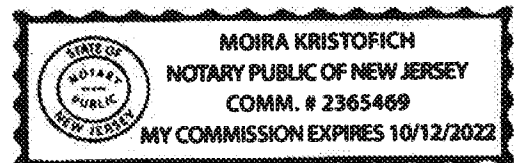
