RELEASE OF PATENT SECURITY INTEREST

THIS RELEASE OF PATENT SECURITY INTEREST (this "Release") is given on March 10, 2021, by BANK OF AMERICA, N.A., AS AGENT, (the "Bank"), to the various owners listed on Schedule A, attached hereto and incorporated herein by this reference, (the "Grantors").

WHEREAS, the Grantors and the Bank are party to (i) that certain Credit Agreement, by and among the Bank, as administrative agent and collateral agent for the lenders party thereto, the Grantors and other parties party thereto from time to time, dated as of February 9, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement") and (ii) that certain First Lien Guaranty dated as of February 9, 2017 (the "Collateral Agreement") and the Grantors, as applicable, are party to a Patent Security Agreement dated as of February 9, 2017, a Patent Security Agreement dated as of June 29, 2017, a Patent Security Agreement dated as of November 12, 2019 (collectively, the "Patent Security Agreements"), as applicable;

WHEREAS, pursuant to the Collateral Agreement and the Patent Security Agreements, the Grantors granted to the Bank, among other collateral, a continuing security interest in all of the Grantors' rights, titles and interests, including goodwill, in, to and under the United States Patents listed on the attached Schedule A (the "Patents");

WHEREAS, the Patent Security Agreements were recorded in the United States Patent & Trademark Office on February 10, 2017 at reel/frame 041674/0931 and updated on November 13, 2018 at reel/frame 047509/092, February 10, 2017 at reel/frame 041675/0029 and updated on November 13, 2018 at reel/frame 047510/0020, June 29, 2017 at reel/frame 042864/0446 and updated on November 13, 2019 at reel/frame 047510/0408 and November 13, 2019 at reel/frame 050994/0031;

WHEREAS, the Grantors have performed all of their respective obligations under the Credit Agreement and accordingly the Bank has agreed to terminate and release their security interest in the Patents, and retransfer and reassign to the Grantors without recourse all of the Bank's right, title and interest in and to those Patents.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby releases any security interest it may have in the Patents, and reassigns any and all right, title and interest it may have in and to those Patents without recourse to the relevant Grantors.


FURTHERMORE, the Bank hereby authorizes the Grantors and its authorized representatives to record this Release with the United States Patent Office and agrees to take all further actions, and provide to the Grantors, all such cooperation and assistance (including without limitation the execution and delivery of any and all documents or other instruments) reasonably requested by the Grantors, at the Grantors' respective sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

THIS RELEASE AND ANY CLAIM, CONTROVERSY OR DISPUTE ARISING HEREUNDER OR RELATED TO THIS RELEASE, WHETHER IN TORT, CONTRACT (AT LAW OR IN EQUITY) OR OTHERWISE, SHALL BE GOVERNED BY AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
