**TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS (this “Release”) is dated as of March 22, 2021 (the “Release Date”), by TRUIST BANK, as successor by merger to SunTrust Bank and as successor by assignment to KeyBank National Association, as collateral agent for the Secured Parties (as defined in the Security Agreement defined below) (in such capacity, the “Agent”), for the benefit of each of HOLMED, LLC, a Delaware limited liability company (“Holmed”), AUTOCAM CORPORATION, a Michigan corporation (“Autocam”), PRECISION ENGINEERED PRODUCTS LLC, a Delaware limited liability company (“Precision”) and TRIGON INTERNATIONAL LLC, a Delaware limited liability company (“Trigon”, and together with Holmed, Autocam and Precision, each a “Grantor” and collectively, the “Grantors”).

WHEREAS, reference is made to (i) that certain Security Agreement, dated as of October 19, 2015, by the Grantors in favor of the Agent (the “Security Agreement”), (ii) that certain Notice of Grant of Security Interest in Patents, dated as of October 19, 2015, by the Grantors in favor of the Agent (the “Patent Security Agreement”) and (iii) that certain Notice of Assignment of Grant of Security Interest in Patents, dated as of September 30, 2016, by KeyBank National Association in favor of the Agent (the “Assignment”);

WHEREAS, pursuant to the Patent Security Agreement, each Grantor pledged and granted to the Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of the patents and patent applications (the “Patent Collateral”) of such Grantor, including, without limitation, those referred to on Schedule I hereto;

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on October 30, 2015 at Reel/Frame 037009/0288;

WHEREAS, the Assignment was recorded with the United States Patent and Trademark Office on October 21, 2016 at Reel/Frame 040093/0588;

WHEREAS, the obligations of the Grantors to the Agent have been paid in full and the Grantors have requested that the Agent release its security interest in the Patent Collateral.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, the Agent hereby, without any representation and warranty and without any recourse (a) terminates the Liens (as defined in the Security Agreement) and security interests created under the Patent Security Agreement in the Patent Collateral, (b) releases its security interest in the Patent Collateral, (c) discharges any and all rights, title and interest it has in and the security interest granted to the Agent in the Patent Collateral, (d) terminates the Patent Security Agreement except for any

provisions therein that expressly survive termination, and (e) assigns, grants and conveys to the applicable Grantor any and all of Agent's right, title and interest in and to the Patent Collateral.

2. Recordation of Release. The Agent understands and agrees that this Release may be recorded by or for each Grantor with the USPTO.

3. Further Actions. The Agent further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that the Grantors may reasonably require to effect the intent and purpose of this Release; provided, that all such documents are to be prepared by counsel to such Grantor and the cost and expense of such documents and actions shall be borne solely by such Grantor.

4. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Patent Security Agreement.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
