1. I am currently the Chief Executive Officer of Excel Scientific LLC, a Delaware limited liability company ("Excel Scientific").

2. From June 26, 2001 through December 30, 2014, Excel Scientific was a California corporation by the name of Excel Scientific, Inc. ("Excel CA"). I was the Chief Executive Officer of Excel CA for the entirety of that period.

3. On December 30, 2014, Excel CA merged with and into Excel Scientific, Inc., a Nevada corporation ("Excel NV"). Excel NV converted to Excel Scientific on December 23, 2020. I was the Chief Executive Officer of Excel NV for the entirety of that period.

4. As Chief Executive Officer, I am an authorized representative of Excel Scientific and I have personal knowledge of the employment practices and intellectual property development efforts of Excel Scientific and its predecessor entities.

5. I am personally familiar with Mr. Paul K. Chadwick, who was hired as a consultant by Excel CA in or about September 1995.


