**AND I HEREBY** further covenant and agree that, without further consideration, I will communicate to ASSIGNEE or its successors, assigns, or nominees any facts known to me respecting THE INVENTIONS and the Patent Application, sign all lawful papers, execute all divisional, continuation, continuations-in-part, substitute, reexamination, reissue, U.S. non-provisional, PCT, PCT-based, national, and regional patent applications, make all rightful oaths, and generally do everything possible to aid ASSIGNEE, its successors, assigns, or nominees to obtain and enforce proper patent protection for THE INVENTION(S) and the Patent Application in all countries.




