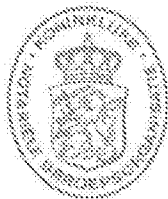

**DECLARATION DEMERGER STICHTING VU-VUMC
(DEMERGER AS DEFINED IN ARTICLE 2:334A SUBSECTION 3 DUTCH CIVIL
CODE (*BURGERLIJK WETBOEK*))**

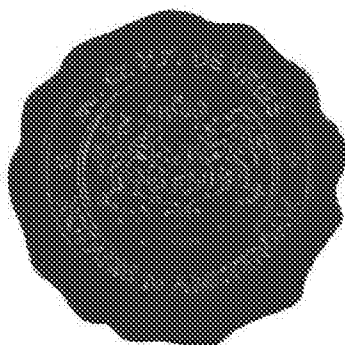
The undersigned:

Paul Pieter de Vries, civil-law notary in Amsterdam,

hereby declares that:

- on 31 December 2015 a deed of demerger as defined in article 2:334a subsection 3 Dutch Civil Code (*Burgerlijk Wetboek*) was executed before Martine Bijkerk, at that time civil-law notary in Amsterdam;
- the demerger came into effect on 1 January 2016;
- parties to the demerger were:
 - a. **Stichting VU-VUmc** (as per 1 January 2016 renamed to: *Stichting VU*), a foundation (*stichting*), incorporated under the laws of the Netherlands with its registered seat in Amsterdam, the Netherlands, and principal place of business in (1081 HV) Amsterdam, De Boelelaan 1105, registered with the trade register under number 53815211 ("**Demerging Legal Entity**"); and
 - b. **Stichting VUmc**, a foundation (*stichting*), incorporated under the laws of the Netherlands with its registered seat in Amsterdam, the Netherlands, and principal place of business in (1081 HV) Amsterdam, De Boelelaan 1117, registered with the trade register under number 64156338 (the "**Acquiring Legal Entity**");
- as a result of the demerger the Acquiring Legal Entity acquired, *inter alia*, all rights accruing from the patents and patent applications owned by the Demerging Legal Entity, as listed in **Annex A** to this declaration, and the invention(s) described therein, including any and all priority rights of the said patents/patent applications and including any and all divisionals and continuations thereof.
