## COMBINED DECLARATION AND ASSIGNMENT

WHEREAS, I, **Woo Jin LEE**, a citizen of the Republic of Korea, with a mailing address of 56, Gosan-ro, Uiwang-si, Gyeonggi-do, 16073, Republic of Korea; and **Hyuk Jin JEONG**, a citizen of the Republic of Korea, with a mailing address of 56, Gosan-ro, Uiwang-si, Gyeonggi-do, 16073, Republic of Korea (hereinafter referred to as "ASSIGNOR"), am a joint inventor of certain new and useful improvements (hereinafter collectively referred to as "INVENTION") in *Thermoplastic Resin Composition and Article Produced Therefrom*, for which an application for United States Letters Patent is being filed concurrently herewith and which application claims priority from an International Application filed on November 18, 2019, under Serial No. PCT/KR2019/015771, and a Korean application filed on November 26, 2018, under Serial No. 10-2018-0147560, all applications listed above being hereinafter referred to as the "APPLICATION"; and

WHEREAS, Lotte Chemical Corporation, a corporation of the Republic of Korea (hereinafter referred to as "ASSIGNEE"), having a principal place of business at 300, Olympic-ro, Songpa-gu, Seoul, 05551, Republic of Korea, has acquired the equitable right, title, and interest—and is desirous of acquiring any remaining right, title, and interest—in and to said INVENTION as described in said APPLICATION, and in and to any and all Letters Patent that shall be granted with respect to said INVENTION in the United States of America and all foreign countries;

NOW, THEREFORE, be it known that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I, the ASSIGNOR, have sold, assigned, transferred, and conveyed unto said ASSIGNEE, its successors and assigns, my

I further acknowledge that said ASSIGNEE has the sole right to determine patent prosecution strategies with respect to said INVENTION and all corresponding applications, and hereby request that Letters Patent be issued in accordance with this assignment.

I further covenant and agree to bind my heirs, legal representatives, and assigns, promptly to communicate to said ASSIGNEE or its representatives any facts known to me relating to said INVENTION, to testify in any interference or legal proceedings involving said INVENTION, to execute any additional papers that may be requested to confirm the right of the ASSIGNEE, its representatives, successors or assigns to secure patent or similar protection for said INVENTION in all countries and to

vest in the ASSIGNEE complete title to said INVENTION and Letters Patent, without further compensation, but at the expense of said ASSIGNEE, its successors, assigns and other legal representatives.
