Pursuant to Title 8, Section 251(c), of the Delaware General Corporation Law, the undersigned corporation does hereby certify as follows:

**FIRST:** The name and state of incorporation of the constituent corporations are: ABBYY Process Intelligence Inc., a Delaware corporation ("ABBYY PI") and ABBYY Development Inc., a Delaware corporation ("ABBYY Development", and together with ABBYY PI, the "Constituent Corporations").

**SECOND:** The Agreement and Plan of Merger, dated as of 8<sup>th</sup> June, 2020 (the "Merger Agreement"), by and among ABBYY Plc, a Cyprus public limited company, ABBYY PI and ABBYY Development, has been approved, adopted, certified, executed and acknowledged by each of the Constituent Corporations in accordance with the requirements of Title 8, Section 251 of the Delaware General Corporation Law.
