ASSIGNMENT

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which I hereby acknowledge, I, **John KATZENELLENBOGEN**, do hereby assign, transfer and set over to said **THE BOARD OF TRUSTEES OF THE UNIVERSITY OF ILLINOIS**, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the said improvements, and the said applications, including the right to claim priority to said applications, and all divisions, continuations and continuations-in-part thereof, and all Letters Patent which may be granted thereon and all reexaminations, reissues, renewals and extensions thereof, and all applications for Letters Patent which may hereafter be filed for said improvements in any country or countries foreign to the United States, and all Letters Patent which may be granted for said improvements in any country or countries foreign to the United States and all reexaminations, reissues, renewals and extensions thereof; and I hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said improvements to the said **THE BOARD OF TRUSTEES OF THE UNIVERSITY OF ILLINOIS**, its successors, legal representatives and assigns, in accordance with the terms of this instrument.


AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;

AND I HEREBY further covenant and agree that I and my heirs, representatives and successors, if any, will communicate to the said **THE BOARD OF TRUSTEES OF THE UNIVERSITY OF ILLINOIS**, its successors, legal representatives and assigns, any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said **THE BOARD OF TRUSTEES OF THE UNIVERSITY OF ILLINOIS**, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.

AND I HEREBY grant Heslin Rothenberg Farley & Mesiti P.C. the power to insert on this assignment any further indication which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.

This assignment agreement may be executed in counterparts.
