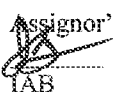

AND I HEREBY FURTHER covenant and agree that this Assignment is effective as of 12 May 2017.

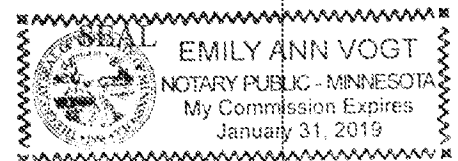
