A. The previous consent of the holders of more than fifty percent (50%) of the issued shares of the Corporation having voting rights expressed by a resolution passed at a meeting of the holders of such shares or by an instrument or instruments in writing signed by the holders of such shares, or

B. The previous consent of the directors of the Corporation expressed by a resolution passed by the directors of the Corporation at a meeting of the board of directors or by an instrument or instruments in writing signed by all of the directors; and

C. Any consents required by the restrictions on transfer contained in the security holders' agreement governing the securities."

6. The amendment has been duly authorized as required by sections 168 and 170 (as applicable) of the *Business Corporations Act*.
