For the avoidance of doubt, the present assignment of the assets in Schedule A includes the assignment of the Inventions identified in Schedule A and covering in whole or in part the same inventions, from which the Inventions in Schedule A claimed priority, and of the right to file patent applications claiming priority thereof in any jurisdiction.



