


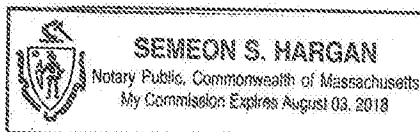
ASSIGNMENT


