- (a) claim priority from the Patent Application in respect of subsequent applications made for the grant of a patent anywhere in the world; and



 - 1.4 The Assignors acknowledge the receipt and adequacy of good and valuable consideration for the acknowledgement and the assignment effected by this Deed.
 - 1.5 The Assignors authorise the Assignee to register this Deed with patent and trademark offices, as required from time to time.
 - 1.6 The Assignors agree to provide any assistance reasonably required by the Assignee in order to give full effect to this Deed (including the execution of any documents). The Assignors irrevocably appoint each of the directors of the Assignee from time to time severally as the Assignors' attorney to do all acts and execute all documents which the Assignors are obliged to do or execute by this clause.


