**DEED OF ASSIGNMENT**

This Deed made this *1st* day of *August* 2019

**BETWEEN**

1. **David Tomlinson** of 12 Miowera Road Northbridge NSW 2063 Australia, (hereinafter called the "First Assignor") of the first part;
2. **Robert Alder** of 1080 Tablelands Road Gin Gin QLD 4671 (hereinafter called the "Second Assignor") of the second part; AND
3. **Uenme Global Pty. Ltd.** (ACN 634 903 610) of 21 Mulgrave Street Gin Gin QLD 4671 Australia (hereinafter called the "Assignee") of the third part;

**RECITALS:**

- A. The First Assignor is the applicant of an invention the subject of an **Australian Provisional Patent application no. 2018903970** filed 19 October 2018 entitled "Use of composition in horticulture" and an **Australian Provisional Patent application no. 2019900823** filed 13 March 2019 entitled "Use of composition for horticulture" (hereinafter called "the Invention")
- B. Following an initial inventive concept by the Second Assignor, the First Assignor and Second Assignor co-invented the Invention.
- C. The First Assignor confirms the Second Assignor is a co-inventor of the Invention.
- D. The First Assignor and Second Assignor have agreed with the Assignee to assign and transfer unto the Assignee the whole right, title and interest in and to the Invention.

**NOW THIS DEED WITNESSETH:**

In consideration of the sum of ten Australian dollars (AU\$10) (the receipt of which is hereby acknowledged by the First Assignor and Second Assignor), the First Assignor and Second Assignor as co-inventors hereby assign to the Assignee free of all encumbrances

- (a) The whole right, title and interest to the Invention;
- (b) The right to apply and to obtain intellectual property rights for the Invention;

(c) The right to apply and obtain intellectual property rights for the invention in any other country of the world whether claiming priority from the abovementioned Australian patent applications or not; and

(d) The First Assignor and Second Assignor agree that they will execute any and all necessary documents to enable the Assignee to have the Assignee entered in such registers of intellectual property as shall be appropriate as being the sole proprietor of the invention.

This Deed is governed by and shall be interpreted in accordance with the law of New South Wales and the parties submit to the jurisdiction of the courts of New South Wales and any other court hearing appeals from such courts.
