- 2 The Inventor hereby warrants that he/she has not made any assignment of the Invention, or of any application or patent therefor, or any other rights that conflict with this agreement, to a party other than the Company, and that the Inventor is not under any obligation to make any assignment of the Invention, application, or patent therefor, or any other rights that conflict with this agreement, to any other party.
- 3 The Inventor hereby confirms that his/her correct full names, addresses and nationalities are as set out above.
- 4 The Inventor hereby confirms that he/she is the only inventor of the Invention.
- 5 The Inventor agrees to advise the Company of any changes of address to enable the Company to send requests for further documents. The Inventor hereby grants power of attorney to any current director of the Company to sign such further documents, to use the Inventor's name, perform such acts, and do any other thing which may be necessary or desirable to enable the Company to obtain for itself or its nominee the full benefit of the provisions of this agreement in the event that for any reason, the Inventor fails to comply within a reasonable time with any such request made by the Company or its representatives.

6 The Inventor further grants the Company's attorneys and authorised representatives including without limitation, employees of Murgitroyd & Company Limited, the power to insert on this assignment any further identification of corresponding patent applications which may be necessary or desirable in order to comply with the rules of the United States Patent Office and corresponding authorities in other territories for recording this document. It is understood and agreed that said the Company's attorneys have represented only the Company and will continue to represent only the Company with respect to this invention.


