ASSIGNMENT OF PATENTS

- 1. <u>Conveyance and Acceptance of Patents</u>. Upon the terms and subject to the conditions of the Asset Purchase Agreement, Assignor hereby, irrevocably, without reservation, sells, transfers, grants, assigns and conveys to Assignee, free and clear of all Encumbrances other than the Permitted Encumbrances, and Assignee hereby purchases, acquires and accepts from Assignor, all of Assignor's right, title and interest in and to the Patents, together with the goodwill of the business symbolized by the Patents, and any and all other rights, privileges, and priorities provided under applicable law associated with respect to the Patents, including, but not limited to, the right of priority, the rights to any extension or renewal of any registration or application, the right to sue for present, past, and future infringement, the rights to use or abandon, the right to make derivative works, the right to reproduce in all formats, and the right to collect and retain any proceeds therefrom.
- 2. <u>Due Authorization</u>. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and any other official of any other applicable governmental authority to record Assignee as the assignee and owner of the Patents, and to issue any and all registrations from any and all applications for registration included in the Patents in and to the name of Assignee.
- 3. <u>Further Assurances</u>. Assignor shall execute and deliver such additional documents, instruments, conveyances and assurances, prepared by Assignee, and take such further actions as may be reasonably required to carry out the provisions hereof and give effect to the transactions contemplated by this Assignment Agreement, including the recordation of this Agreement and perfection of Assignee's interest in and to the Patents.
- 4. <u>Purchase Agreement Controls.</u> Nothing in this Assignment Agreement shall be deemed to supersede, diminish, enlarge or modify any of the provisions of the Asset Purchase Agreement, all of which survive the execution and delivery of this Assignment Agreement as provided and subject to the limitations set forth in the Asset Purchase Agreement. In the event of any conflict or inconsistency between the terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement shall govern and control.
- 5. <u>Assignment; Governing Law; Jurisdiction</u>. This Assignment Agreement and the provisions herein contained shall be binding upon and inure to the benefit of Assignor, Assignee and their

respective successors and assigns. The provisions of Section 11.08 (Governing Law; Jurisdiction) of the Asset Purchase Agreement shall apply to this Assignment Agreement.

6. <u>Counterparts</u>. This Assignment Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. A signed copy of this Assignment Agreement delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment Agreement.


