FURTHER, the above-granted rights, titles, and interests are to be held and enjoyed by Assignee, for its own use and behalf and the use and behalf of its successors, legal representatives, and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor had this sale and assignment not been made.

FURTHER, the Assignor and Assignee agree that this Assignment will be governed by the governing law and venue provisions of the Patent Purchase Agreement. To the extent of any conflict or inconsistency between the terms and conditions of this Assignment and the Patent Purchase Agreement, the Patent Purchase Agreement will prevail and govern the rights and obligations of the Parties hereto and the scope of assignment of the Patents. This Assignment may be executed in any number of counterparts, each of which will be deemed an original, and all of which together will constitute one and the same instrument. Delivery of an executed counterpart of a signature page to this Assignment by facsimile or electronic mail will be as effective as delivery of a manually executed counterpart of this Assignment. This Assignment, along with its Schedule and the Patent Purchase Agreement and its Exhibits constitutes the entire understanding and agreement of the Parties hereto with respect to the subject matter hereof and supersedes all prior and contemporaneous agreements or understandings, inducements or conditions, express or implied, written or oral, between and among the Parties with respect hereto. This Assignment may not be supplemented, altered, or modified in any manner except by a writing signed by all Parties hereto. The failure of any party to enforce any terms or provisions of this Assignment will not waive any of its rights under such terms or provisions. This Assignment is binding upon and inures to the benefit of the Parties hereto and their respective successors and assigns.
