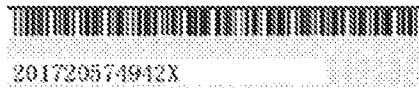

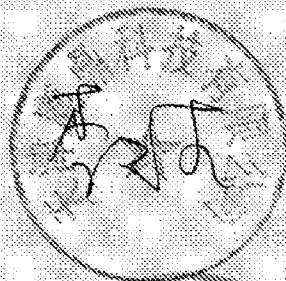

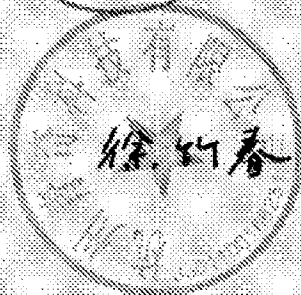

Declaration Re Patent Application Ownership

I, **Yun Ji**, do hereby declare and say:

1. I am a Legal Affair Manager in BEIJING DIDI INFINITY TECHNOLOGY AND DEVELOPMENT CO., LTD. ("DIDI"), which is located at No. 8 Dongbeiwang West Road, Haidian District, Beijing, China, 100193. My main focus is intellectual property and I provide patent services to business and corporate branches of DIDI, including DIDI's subsidiaries.
2. HANGZHOU QINGQI SCIENCE AND TECHNOLOGY CO., LTD. ("QINGQI"), which is located at Room 301, No. 108 Xincheng Road, Nanyuan street, Yuhang District, Hangzhou, Zhejiang and is an affiliate company fully owned by DIDI. With substantial considerations, QINGQI acquired a series of inventions based on Chinese Patent Applications listed in Exhibit A ("CN Applications") from TIANJIN LUDING TECHNOLOGY CO., LTD. ("LUDING"), which is located at Room 204-78, Building 4, Jingbin Ruicheng, Jingbin Industrial Park, Wuqing District, Tianjin (centralized office area) and is the original owner and applicant of the CN Applications.
3. I participated in the entire process of negotiation and agreement signing between QINGQI and LUDING, for the acquisition of the inventions based on the CN Applications. I also came into contact with a number of engineers from LUDING during this process.
4. After acquiring the inventions disclosed in the CN Applications, QINGQI, as applicant, filed a number of PCT Applications, as listed in Exhibit B, based on the inventions disclosed in the CN Applications, and claiming priority to the CN

Applications. Thereafter, QINGQI, as applicant, filed a number of US Applications (listed in Exhibit C) as national phase or by-pass continuation of the PCT Applications.

5. We attempted to acquire the LUDING inventors' signatures for the assignments (from inventors to LUDING) and declarations in the US Applications. However, we could not obtain their contact information and our efforts were not successful.

6. To the best of my knowledge, the inventors of the US Applications were all LUDING's employees and all the inventions disclosed in the CN Applications were made as part of the inventors' employment by LUDING. Chapter 1, Article 6 of the Patent Law of the People's Republic of China recites:

An invention-creation, made by a person in execution of the tasks of the entity to which he belongs, or made by him mainly by using the material and technical means of the entity is a service invention-creation. For a service invention-creation, the right to apply for a patent belongs to the entity. After the application is approved, the entity shall be the patentee.

Pursuant to this provision, I submit that LUDING was the rightful owner of the inventions disclosed in the CN Applications before the ownership of the inventions was transferred to QINGQI.

7. As indicated in paragraph 4 above, the US Applications, which are national phase or by-pass continuation of the PCT Applications, are based on the inventions disclosed in the CN Applications. Therefore, I further submit that QINGQI is the rightful owner of the US Applications.

8. As a Legal Affair Manager, a participant in the deal between QINGQI and

LUDING, and a witness thereof, I believe I am fully authorized to attest to the facts and reach the conclusion asserted above. I hereby declare that all statement made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the application or any patent issued therefrom.
