Further, Road Shower, LLC hereby covenants and agrees to and with Yakima Products, Inc., and its successors and assigns, at the time of execution and delivery of these presents, that Road Shower, LLC is the sole and lawful owner of the entire right, title, and interest in and to the inventions, and that the same are unencumbered, and that Road Shower, LLC has good and full right and lawful authority to sell and convey the same in the manner herein set forth.

Further, Road Shower, LLC agrees that it will communicate to Yakima Products, Inc., or its representatives, any known facts respecting the inventions, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, substitution, and extension applications, execute all necessary assignment papers to

cause any and all of said Letters Patent to be issued to Yakima Products, Inc., make all rightful oaths, and generally do everything possible to aid Yakima Products, Inc., and its successors and assigns, to obtain and enforce proper protection for the invention in the United States and in any and all foreign countries.
