LOFT CRAG LIMITED a company incorporated and registered in the Isle Of Man (009688V) and whose registered office is at St. Mary's, The Parade, Castletown, Isle Of Man, IM9 1LG (the "Assignor"); and

LOFT CRAG (N.I.) LIMITED a company incorporated and registered in Northern Ireland (NI634593) and whose registered office is at Murray House, Murray Street, Belfast, BT1 6DN (the "Assignee").

WHEREAS, pursuant to an Asset Purchase Agreement dated 16 February 2016 (the "Purchase Agreement"), under which the Assignor agreed to assign and transfer to the Assignee all of the Assignor's right, title and interest in, to and under all of the Assigned Assets, including the Assigned Patent Application and the Assigned Trade Mark (as listed in Schedule A), together with the goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Assignor, the Assignor hereby assigns, sells, transfers and set over to the Assignee, its successors and legal representatives, any and all rights that they have in or to the Assigned Assets including the right to claim priority.

AND the Assignors hereby covenant and agree that they have the full right to convey the entire interest herein assigned, and that they have not executed, and will not execute, any agreement in conflict herewith.

This Agreement is executed and delivered pursuant to, is in accordance with, and is subject to, all of the representations, warranties, covenants and indemnities set forth in the Purchase Agreement, all of which shall survive the consummation of the transactions contemplated hereby on the basis and to the extent set forth in the Purchase Agreement. Nothing contained in this Agreement shall in any way supersede, modify, replace, amend, change, rescind, waive, exceed, expand, enlarge or in any way affect the provisions set forth within the Purchase Agreement. In the event that any provision of this Agreement shall be construed to conflict with a provision in the Purchase Agreement, the terms of the Purchase Agreement shall prevail.


This Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.


