1. This Certificate of Amendment (the "Certificate of Amendment") amends the provisions of the Certificate of Incorporation of the Corporation filed with the Secretary of State on December 4, 2013, as amended (the "Certificate of Incorporation").
2. Article First of the Certificate of Incorporation is hereby amended by deleting it in its entirety and replacing it with the following:  

**"FIRST:** The name of the corporation is Artio Medical, Inc. (the "Corporation")."

4. This amendment was duly adopted in accordance with the provisions of Sections 228 and 242 of the General Corporation Law of the State of Delaware.
5. All other provisions of the Certificate of Incorporation shall remain in full force and effect.
