RELEASE OF SECURITY INTEREST IN PATENTS

This RELEASE OF SECURITY INTEREST IN PATENTS (this "**Release**"), dated as of April 26, 2021, is made by Western Alliance Bank, an Arizona corporation (the "**Lender**").

WHEREAS, pursuant to that certain Business Financing Agreement, dated as of May 23, 2017 between the Lender and Digital Turbine, Inc. (the "**Grantor**"), the Grantor executed in favor of the Lender that certain Intellectual Property Security Agreement, dated as of May 23, 2017 (the "**Intellectual Property Security Agreement**"), between the Lender and the Grantor, wherein the Grantor granted to the Lender a security interest in all of the Grantor's right, title and interest in the Intellectual Property Collateral (as defined in the Intellectual Property Security Agreement), including without limitation the intellectual property set forth on Schedule A attached hereto (collectively, the "**Patents**");

WHEREAS, the Intellectual Property Security Agreement was filed at the United States Patent and Trademark Office on May 25, 2017, at Patent Reel 042507, Frame 0074; and

WHEREAS, the Grantor has requested that the Lender release and reassign its interest in the Patents to the Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Lender hereby:

1. Discharges, relinquishes, terminates, cancels and releases the lien on and any and all right, title and interest in and to: (i) the Patents, (ii) all extensions and renewals of and amendments to the Patents, (iii) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to the Patents, (iv) any and all claims and causes of action, with respect to the Patents, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages and/or (v) any goodwill associated with the Patents, without recourse or representation or warranty, express or implied of any kind;
2. Reassigns to the Grantor any and all liens, security interests, right, title and interest of the Lender in the Patents, without recourse or representation or warranty, express or implied, of any kind; and
3. Authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.


