
for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; and all forms of industrial property protection, including, without limitation, patents, utility models and designs which may be granted for said invention in any country or countries and all extensions, renewals, reexaminations and reissues thereof, to the full end of the term for which said letters patent have been granted or reissues may be granted, and for claims for damage by reasons of infringement past and present, as fully and entirely as the same would have been held by KOBE UNIVERSITY had this Assignment and sale not been made.
