proper patent protection for the Patents in any and all countries, all such actions to be at the sole expense of assignee.

AND, Assignor HEREBY further agrees that, from and after the date of this Patent Assignment & Declaration, Assignee has succeeded to all of Assignor's right, title, interest and standing to receive all rights and benefits pertaining to the Patents, institute and prosecute all suits and proceedings pertaining to the Patents, take all actions that Assignor, in Assignor's sole discretion, may deem necessary or proper to collect, assert, or enforce any claim, right, title or interest of any kind under the Patents, including, without limitation, the right to sue for all past, present and future infringements or other violations of any rights relating thereto, to settle, defend, compromise and retain proceeds from any actions, suits, or proceedings relating to the transferred and assigned rights, title, interest, and benefits, in any and all countries, and do all other such acts and things in relation thereto as Assignor, in its sole discretion, deems advisable.


