ASSIGNOR hereby authorizes and requests the Patent Office Officials in the United States and its territorial possessions, and in any and all countries and Regional Patent Offices, including, without limitation, the PCT Contracting States, to issue, when granted, any Letters Patent thereon, and any and all divisions, continuations, substitutions, renewals, re-examinations, extensions and reissues thereof, to said *ASSIGNEE*, its successors and assigns, as the assignee of the entire right title and interest in and to the same, for the sole use and behalf of the *ASSIGNEE* and the *ASSIGNEE'S* successors and assigns, to the full end of the term for which the Letters Patent may be granted, including the term of any and all divisions, continuations, substitutions, renewals, re-examinations, extensions and reissues thereof, as fully and entirely as the same would have been held by the *ASSIGNOR* had this assignment not been made;
