WHEREAS, I, *Allison Zupon*, (the "ASSIGNOR"), have invented certain new and useful improvements in the properties listed herein.



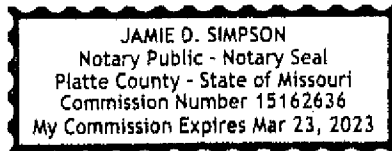
