AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.

AND I HEREBY further covenant and agree that I and my heirs, representatives and successors, if any, will communicate to the said **ANGIODYNAMICS, INC.**, its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said **ANGIODYNAMICS, INC.**, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.

AND I HEREBY grant Heslin Rothenberg Farley & Mesiti P.C. the power to insert on this assignment any further indication which may be necessary or desirable to comply with the rules of the United States Patent and Trademark Office for recordation of this document.

AND I HEREBY declare that all statements made herein are of my own knowledge and are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that any willful false statements and the like so made in this declaration are punishable by fine or imprisonment of not more than five (5) years, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the application or any patent issued thereon.




