Assignors hereby authorize and request the Commissioner for Patents of the United States and any official of any foreign country whose duty it is to issue patents on the Applications as described above, to issue all Letters Patent for this Invention to Assignee in accordance with the terms of this assignment;

Assignors hereby covenant that they have the full right to convey all rights and interests assigned by this Assignment, that there are no rights or interests outstanding inconsistent with the rights and interests granted herein, and that they have not and will not execute any instrument or grant or transfer any rights or interests inconsistent with the rights and interests granted herein.


Assignors hereby further covenant and agree that they will, without further consideration, communicate with Assignee any facts known to them respecting this invention, and testify in any legal proceeding, sign all lawful papers that may be necessary or desirable to perfect the title to this invention in said assignee, its successors or assigns, execute all divisional, continuation, and reissue applications, make all rightful oaths and generally do everything possible to aid assignee, its successors and assigns, to obtain and enforce Letters Patent for this invention in the United States and any foreign country, it being understood that any expense incident to the execution of such papers shall be borne by the Assignee, its successors and assigns.

This Assignment does not alter or modify any of the terms of, or the rights of the parties with respect to, any other agreements between Skyline and Assignee, including the Design Services Agreement dated October 30, 2020.


