Assignors authorize the Commissioner for Patents to record Assignee as the owner of the Patent Applications, including any continuations, divisions, continuations-in-part, reissues,

reexaminations or extensions thereof, and to issue any and all letters patents of the United States thereon to Assignee, as assignee of the entire right, title and interest in and to the same, for the sole use and enjoyment of Assignee, its heirs, successors, assigns or other legal representatives.

If at any time after the date of this Assignment any further action is necessary or desirable to carry out the purposes of this Assignment, the parties hereto shall take or cause to be taken all such necessary action, including, without limitation, the execution and delivery of such further instruments and documents as may be reasonably requested by the other party for such purposes or otherwise to consummate and make effective this Assignment.
