The adoption of the following resolution:

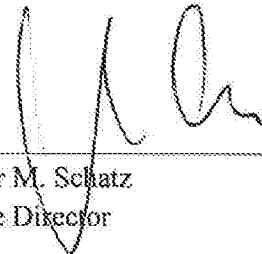
