(the "Assignee")

PREAMBLE

WHEREAS the Assignor is the sole owner of the entire right, title and interest in and to the SLEDMILL patent bearing patent number US 10,493,315 B2 in the United States Patent and Trademark Office for use in connection with the services set out in the respective descriptions thereof attached hereto as Schedule "A" (the "**Patent**");

WHEREAS in consideration of the payment of forty (\$40.00) by the Assignee to the Assignor, the Assignor desires to sell, transfer and assign to the Assignee all of the Assignor's right, title and interest in and to the Patent application and/or registration together with the goodwill of the business in connection with which the Patent is used and which is symbolized by the Patent, along with the right to recover from third parties damages for past infringements thereof including the right to institute or maintain judicial or administrative proceedings for past, present or future infringements of the Patent; and

WHEREAS, the Assignee desires to acquire from the Assignor all of Assignor's right, title and interest in and to the Patent application and/or registration, together with the benefit of any use of the Patent by the Assignor, and the goodwill of the business relations to the Patent and to the wares or services associated with it, to hold unto the Assignee absolutely.

NOW, THEREFORE, in consideration of the payment of forty dollars (\$40.00) and for other good and valuable consideration, the receipt, sufficiency and adequacy of which is hereby acknowledged, the Assignor and the Assignee hereby agree as follows:

1. Patent Assignment. The Assignor hereby sells, transfers and assigns to the Assignee, its successors and assigns, the Assignor's entire right, title and interest in and to the Patent application and/or registration, together with (i) the benefit of any use of the Patent by the Assignor, (ii) the goodwill of the business relations to the Patent and to the wares or services associated with it, (iii) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Patent, to hold unto the Assignee absolutely.
