RELEASE OF SECURITY INTEREST IN PATENTS

THIS RELEASE OF SECURITY INTEREST IN PATENTS (the "*Release*") is made as of May 7, 2021, by BMO HARRIS BANK N.A., a national banking association ("*Lender*"). Lender hereby authorizes the Grantor (or its designees) to file this Release with the United States Patent and Trademark Office and any other applicable governmental authorities worldwide.

3. Lender shall execute such documents and instruments and take such further actions as may be reasonably required or desirable to carry out the provisions of this Release.
