Assignment of Invention

WHEREAS WE, Remy KURTZ, Patrice CAVAGNE and Delphine VALLIER, have invented certain new and useful improvements documented in a patent application entitled, AIR SEPARATION UNIT BY CRYOGENIC DISTILLATION, for which a United States patent application was filed on July 16, 2020, having U.S. Application No. 16/962,823;

Further, I, agree that I will communicate to said ASSIGNEE or its representatives any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all non-provisional, divisional, continuation, substitute, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said ASSIGNEE, make all rightful oaths, and, generally do everything possible to aid said ASSIGNEE, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and its territorial possessions.
