

THIS GLOBAL IP ASSIGNMENT DEED is dated 30 April 2020

PARTIES:

- (1) MYDRIVE SOLUTIONS LIMITED, a company incorporated in England and Wales under company number 07330334, having its registered office is at Unit 02.02.1, The Leather Market, Weston Street, London, SE1 3ER (the Assignor); and
- (2) GENERALI JENIOT S.P.A., a company incorporated in Italy under fiscal code and VAT no. 06224480159, having its registered office at Piazza Tre Torri no. 1, 20145, Milan, Italy (the Assignee).

(each a Party and together, the Parties).

WHEREAS:

- (A) This Deed is entered into pursuant to an asset transfer agreement dated on or around the date of this Deed between the Assignor and the Assignee (the Asset Transfer Agreement).
- (B) The Assignor has agreed to enter into this Deed to assign to its right, title and interest in the Owned IP to the Assignee.

IT IS AGREED:

1. Definitions and Interpretation

- 1.1 Words and expressions used in this Deed shall be interpreted in accordance with Schedule I.
- 1.2 Capitalised terms used but not defined in this deed shall have their respective meanings given to them in the Asset Transfer Agreement.

2. Assignment

- Pursuant to and for the consideration set out in the Asset Transfer Agreement and with effect from the date of this Deed, the Assignor hereby assigns to the Assignee absolutely with full title guarantee its right, title and interest in the Owned IP, including without limitation:
 - (a) all statutory and common law rights attaching to the Owned IP, together with the goodwill of the business relating to the goods and services in respect of which that Owned IP is registered or used; and

(b) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, unauthorised use or other cause of action arising from ownership of any of these Owned IP, whether occurring before, on or after the date of this Deed. 3. Legal Relationship

Nothing in this Deed shall constitute a partnership between the Parties nor make any Party the agent of any other Party for any purpose.

4. Further Assurances

The Assignor shall, at the Assignee's cost, do anything that is required by law or otherwise that may be necessary to vest in the Assignee the full benefit of the right, title and interest assigned to the Assignee under this Deed and to otherwise implement and give effect to this Deed.

5. Whole Agreement

The Parties agree that the Transaction Documents (as defined in the Asset Transfer Agreement) contain the whole agreement between the Parties relating to the subject matter of this Deed. This Deed shall not vary or otherwise affect the terms of, or the rights or obligations of the Parties under, the Asset Transfer Agreement.

6. Counterparts

This Deed may be executed in any number of counterparts, and by each Party on separate counterparts. Each counterpart is an original, but all counterparts shall together constitute one and the same instrument. Delivery of a counterpart of this Deed by e-mail attachment or telecopy shall be an effective mode of delivery.

7. Variations

No amendment of this Deed shall be valid unless it is in writing and duly executed by or on behalf of all of the Parties to it.

8. Invalid Terms

- 8.1 Each of the provisions of this Deed is severable.
- 8.2 If and to the extent that any provision of this Deed:
 - 8.2.1 is held to be, or becomes, invalid or unenforceable under the law of any jurisdiction; but

8.2.2 would be valid, binding and enforceable if some part of the provision were deleted or amended,

then the provision shall apply with the minimum modifications necessary to make it valid, binding and enforceable and neither the validity or enforceability of the remaining provisions of this Deed, nor the validity or enforceability of that provision under the Law of any other jurisdiction, shall in any way be affected or impaired as a result of this Clause 8.2.

8.3 The Parties shall negotiate in good faith to amend or replace any invalid, void or unenforceable provision with a valid, binding and enforceable substitute provision or provisions, so that, after the amendment or replacement, the commercial effect of the Deed is as close as possible to the effect it would have had if the relevant provision had not been invalid, void or unenforceable.

9. Rights of Third Parties

Except as expressly stated in this Deed, no person who is not a Party to this Deed may enforce any of its terms under the Contracts (Rights of Third Parties) Act 1999.

10. Governing Law and Jurisdiction

- 10.1 This Deed and any disputes shall be governed by, and interpreted in accordance with, English law.
- 10.2 The Parties irrevocably agree that the English courts shall have exclusive jurisdiction in relation to all disputes and waives any objection to the exercise of that jurisdiction.

Schedule 1 DEFINITIONS AND INTERPRETATION

1. Definitions.

Asset Transfer Agreement is defined in Recital (A);

- (d) copyright, database rights, rights in designs, and semiconductor topography rights;
- (e) any other intellectual property rights;
- (f) rights to sue for unfair competition or any other antitrust related matters (to the extent these rights exist); and
- (g) all rights or forms of protection, subsisting now or in the future, having equivalent or similar effect to the rights referred to in paragraphs (a) to (f) above,

in each case: (i) anywhere in the world; (ii) whether unregistered or registered (including all applications, rights to apply and rights to claim priority); and (iii) including all divisionals, continuations, continuations-in-part, reissues, extensions, re-examinations and renewals;

Owned IP means, with the only exception of the Excluded IP, all the Intellectual Property Rights owned by the Assignor including:

- (a) the Software;
- (b) the Patents;
- (c) the Trade Marks;
- (d) Domain Names;

- (e) Websites;
- (f) rights arising under or in connection with the Contracts (as defined in the Asset Transfer Agreement); and
- (g) any other Intellectual Property Rights owned by the Assignor that is used in relation to the Business Assets (as defined in the Asset Transfer Agreement),

and in each case, all rights to bring and defend claims or actions in relation to the above, whether accruing before, on, or after Closing, including all rights to and claims for recovery of damages, restitution, and injunctive and other legal or equitable relief for past, present, or future infringement, misappropriation, or other violation thereof;

Patents means the patents and/or patent applications owned by or registered in the name of the Assignor, including those set out in Schedule 3 (but excluding the patents in the Excluded IP);

Software means any object code, source code, computer program (comprising of a series of instructions, rules, routines or statements, regardless of the media in which they are recorded), recorded information (including design details, algorithms, processes, flow charts, formulas and related material) and other technology and all related technical and operational documentation (including all log-on details and administrator credentials) owned by, or licensed to, the Assignor, including those set out in Schedule 2:

Trade Marks means the trade marks owned by or registered in the name of the Assignor, including those set out in Schedule 4; and

Websites means the websites and any associated content, infrastructure, architecture, extension, tool, database owned by the Assignor, including that used in relation to the Business Assets (as defined in the Asset Transfer Agreement), and comprising those websites and content that are hosted on the Domain Names or on any other device, support or storage medium owned by, or used by, the Assignor.

2. Interpretation.

In this Deed, unless the context requires otherwise:

- (a) references to a *person* include any individual, firm, body corporate (wherever incorporated), government, state or agency of a state or any joint venture, association, partnership, works council or employee representative body (in any case, whether or not it has separate legal personality);
- (b) references to a paragraph, clause or Schedule are to those of this Deed;
- (c) headings do not affect its interpretation;
- (d) the singular shall include the plural and vice versa, and references to one gender include all genders;

- (e) references to any English law legal term or concept shall, in respect of any jurisdiction other than England and Wales, be construed as references to the term or concept that most nearly corresponds to it in that jurisdiction;
- (f) any phrase introduced by the terms *including*, *include*, *in particular* or any similar expression shall be construed as merely illustrative and shall not limit the sense of the words preceding those terms; and
- (g) a reference to a right or an obligation of the Assignor in respect of the Owned IP shall be to the right or obligation of the Assignor in respect of the Owned IP that it owns.
- 3. Enactments. Except as otherwise expressly provided in this Deed, any reference to an enactment (which includes any legislation in any jurisdiction) includes references to: (i) that enactment as amended, consolidated or re-enacted by or under any other enactment whenever made; (ii) any enactment that that enactment re-enacts (with or without modification); and (iii) any subordinate legislation (including regulations) whenever made under that enactment, as amended, consolidated or re-enacted as described at (i) or (ii), except to the extent that any of the matters referred to in (i) to (iii) occurs on or after the date of this Deed and increases or alters the liability of a Party under this Deed.
- Schedules. The Schedules comprise schedules to this Deed and form part of this Deed.
- 5. Inconsistencies. If there is any inconsistency between any definition set out in this Schedule and a definition set out in any clause or any other Schedule, then, for the purposes of construing that clause or Schedule, the definition set out in that clause or Schedule shall prevail.
