

In the event that any of the Scheduled Patents shall become due for any maintenance filings or other recordings during the Interim Period, Assignor shall likewise cooperate with Assignee’s requests and hereby consent and grant to Assignee the right to take whatever action is necessary, in Assignee’s reasonable judgment, and at Assignee’s expense, to maintain and enforce all registrations and other filings in the PTO. All recordings and filings of assignments of the Scheduled Patents and other materials confirming ownership by Assignee shall be made at Assignee’s sole expense.


