CERTIFICATE OF SEGREGATION

In Donostia - San Sebastián, 1 January 2020

We hereby inform you that on 15 May 2018, the ordinary General Universal Board of Shareholders of GRAPHENEA, S.A. and the sole partner of GRAPHENEA SEMICONDUCTOR, S.L.U. have approved the segregation (the "Segregation") of an autonomous economic unit of GRAPHENEA, S.A. in favour of GRAPHENEA SEMICONDUCTOR, S.L.U. (the "Beneficiary Company").


Through the Segregation, GRAPHENEA, S.A. will transfer en masse, without being dissolved, part of its assets materialised in the elements listed with the business conducted by GRAPHENEA, S.A. relative to "the activities of research, development, production and sale of CVD, chemical vapour deposition, graphene" (the "Segregated Assets") to GRAPHENEA SEMICONDUCTOR, S.L.U., who shall acquire, by universal succession, all the rights and obligations inherent to the Segregated Assets, as provided under Article 71 of Law 3/2009 of 3 April on Structural Modifications of the Commercial Companies ("LME").

The purpose of the Segregation is to rationalise and rearrange the activities of GRAPHENEA, S.A., in order to create an organisational structure which allows the different economic activities thereof to be managed in a more independent, efficient and professional manner, taking into account the particularities of each of these activities, and considering that the Beneficiary Company has a different working method in regard to the type of client it deals with (both internal and external), segregation of these activities is considered appropriate so as to favour placing a greater emphasis on the business of the segregated business unit and its managers, taking said peculiarities into account in order to achieve a higher return from the different business areas, separating the liabilities and responsibilities and allowing for better financing of their activities.

The aforementioned business succession is effective as of 18 July 2018, the date on which the corresponding Segregation instrument is registered in the Companies Registry.


Por medio de la presente ponemos en su conocimiento que el 15 de mayo de 2018, la Junta General Universal Ordinaria de Accionistas de GRAPHENEA, S.A. y el socio único de GRAPHENEA SEMICONDUCTOR, S.L.U. han aprobado la segregación (la "Segregación") de una unidad económica autónoma de GRAPHENEA, S.A. a favor de GRAPHENEA SEMICONDUCTOR, S.L.U. La Segregación tiene como objetivo la racionalización y reordenación de las actividades de GRAPHENEA, S.A., con el objetivo de crear una estructura organizativa que permita gestionar de manera más independiente, eficiente y profesional las diferentes actividades económicas de la misma, atendiendo a las particularidades de cada una de estas actividades, y considerando que la Sociedad Beneficiaria tiene una operativa de trabajo diferente en cuanto al tipo de cliente al que atiende (tanto interno como externo), se considera conveniente la separación de estas actividades para favorecer un mayor enfoque en el negocio de la unidad de negocio segregada y de sus responsables, atendiendo a dichas peculiaridades para conseguir un incremento de rentabilidad de las diferentes áreas de negocio, separando los riesgos y responsabilidades y permitiendo una mejor financiación de sus actividades.
