Application and the full and exclusive benefit and advantage thereof including the right to apply for and obtain patents for the Inventions throughout the World including the right to claim priority and to sue for damages and other remedies in respect of any infringement of the Application which may have occurred prior to the date hereof TO HOLD the same unto the Assignee absolutely.

- (2) The Assignor hereby covenants with the Assignee that the Assignor will at the expense of the Assignee execute sign and do all such instruments, applications, documents, acts and things as may reasonably be required by the Assignee to enable the Assignee (or the nominee of the Assignee) to enjoy the full benefit of the property and rights hereby assigned and to apply, prosecute and obtain any patents or other forms of protection throughout the world in respect of the Application or the Inventions and to vest the same in the Assignee or as the Assignee shall direct.

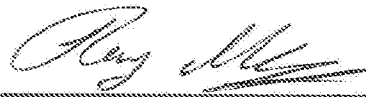

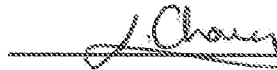

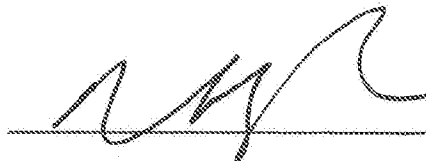
