NOTICE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

WHEREAS, States Title Holding, Inc., a Delaware Corporation, and Title Agency Holdco, LLC, a Delaware limited liability company (each a "Grantor" and collectively, the "Grantors") have entered into a Loan and Security Agreement, dated December 31, 2020 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement"), in favor of Hudson Structured Capital Management Ltd., as the Agent for itself and certain lenders (in such capacity, together with its successors and assigns, if any, the "Agent"); and

WHEREAS, pursuant to the Security Agreement, the Grantors have granted to the Agent for the benefit of the Lenders (as defined in the Security Agreement) a continuing security interest in all right, title and interest of the Grantors in, to and under the Trademarks and Patents (as defined in the Security Agreement), together with, among other things, the goodwill of the business symbolized by the Trademarks, and the applications and registrations thereof, including those set forth on Schedule A below, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"), to secure the payment, performance and observance of the Obligations (as defined in the Security Agreement).


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantors do hereby pledge and grant to the Agent for the benefit of the Agent and the Lenders a continuing security interest in the Collateral to secure the payment and performance of the Obligations.

The Grantors do hereby further acknowledge and affirm that the rights and remedies of the Agent with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


