RELEASE OF SECURITY INTEREST IN PATENTS

This RELEASE OF SECURITY INTEREST IN PATENTS (this “Release”), dated as of May 14, 2021 (the “Effective Date”), is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as collateral agent (in such capacity, the “Collateral Agent”), in favor of U. S. SECURITY ASSOCIATES, INC. (the “Grantor”). All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed to them in the Patent Security Agreement (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain Collateral Agreement, dated as of April 8, 2021 in favor of Collateral Agent (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), the Grantor executed and delivered that certain Patent Security Agreement, dated as of April 8, 2021 (the “Patent Security Agreement”), which was recorded with the United States Patent and Trademark Office (“USPTO”) on April 8, 2021 at Reel/Frame 055926/0391;

WHEREAS, pursuant to the Collateral Agreement and the Patent Security Agreement, the Grantor granted to the Collateral Agent, its successors and assigns for the benefit of the Secured Parties, a security interest (the “Security Interest”) in all of the Grantor’s right, title and interest in, to all Patents, including those listed on Schedule I attached hereto, (the “Patent Collateral”); and

WHEREAS, the Collateral Agent and the Grantor acknowledge that the requirements for releasing the Security Interest in the Patent Collateral have been met.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, hereby (a) terminates and cancels the Patent Security Agreement, (b) releases, discharges, terminates and cancels the Security Interest in the Patent Collateral, and (c) re-assigns to the Grantor any right, title or interest it may have in the Patent Collateral, in each case without recourse to the Collateral Agent and without representation or warranty of any kind.


