ARTICLES OF AMENDMENT  
TO THE  
CHARTER OF

1. The Charter of AOL Advertising Inc. is hereby amended by deleting Article First in its entirety and replacing it with the following (the "Amendment"):


"FIRST: The name of the corporation (which is hereinafter called the "Corporation") is Oath (Americas) Inc."
