## ASSIGNMENT

I. WHEREAS, I. Michael A. Boss, residing in Malvern, County of Chester, Commonwealth of Pennsylvania, have invented, together with other joint inventors, certain new and useful improvements in MRI PHANTOM INCLUDING MRI COMPATIBLE TEMPERATURE MEASUREMENT DEVICE AND PRESSURE EXPANSION BLADDER DEVICE, described and claimed in United States Provisional Patent Application filed June 16, 2018, bearing serial number 62/685,994, in United States Provisional Patent Application filed May 10, 2019, bearing serial number 62/846,223 and claimed in U.S. Patent Application filed June 17, 2019, bearing serial number 16/443,323 and in certain new and useful improvements in MRI PHANTOM HAVING FILAMENTS OF INTEGRAL TEXTILE AXON SIMULATIONS AND ANISOTROPIC HOMOGENEITY MRI PHANTOM USING THE FILAMENTS described and claimed in International PCT Patent Application filed June 17, 2019, bearing serial number PCT/US19/37525 (herein "said applications");

II. AND, WHEREAS Psychology Software Tools, Inc, a corporation of Pennsylvania, having a place of business at 311 23rd St. Ext. Suite 200, Sharpsburg, PA 15215-2821, hereinafter called the "assignee", is desirous of acquiring the entire right, title, and interest in and to the undersigned's interest in said application and the inventions and improvements therein disclosed, except for use of the rights in educational and research applications.

I covenant that I am the lawful owner of my interest in said applications, inventions and improvements, that the same are unencumbered, except as the undersigned might be otherwise obligated to the assignee, that no license has been granted to make, use, or sell the said inventions or improvements or any of them, and that I have the full right to make this assignment.

V. And for the consideration aforesaid, I agree that I will communicate to said assignee or the representatives thereof any facts known to us respecting said inventions and improvements, and will, upon request, but without expense to me, testify in any legal proceedings, sign all lawful papers, execute all regular, divisional, reissue, continuation, continuation-in-part, renewal, and/or extension applications, make all rightful oaths, and generally do all other and further lawful acts, deemed necessary or expedient by said assignee or by counsel for said assignee, to assist or enable said assignee to obtain and enforce full benefits from the rights and interests herein assigned. I acknowledge that I retained rights for educational and research purposes and acknowledge that these rights do not extend to commercialization of inventions set forth in the inventions.

VI. I, the undersigned hereby assign my entire right, title and interest as set forth in sections I-V above.
