ASSIGNMENT

No. 17/288,035, filed April 23, 2021, and in and to said application and any Letters Patent that may be granted in pursuance of said application and any divisional, continuation or continuation-in-part application thereof, and in and to any reissue or re-examination of any such patent, and in and to any patent applications which may be or have been filed on said invention in countries foreign to the United States and any Letters Patent granted thereon.

Fondazione agrees to execute all papers, including those required for the United States and foreign applications, and to perform such other proper acts as Specto may deem necessary to secure to said corporation or its designees the rights herein assigned.


