RELEASE OF PATENT SECURITY AGREEMENT

This RELEASE OF PATENT SECURITY AGREEMENT (this "Release"), dated as of June 4, 2021, is made by BANK OF MONTREAL ("BOM"), as the secured party (together with its successor; the "Secured Party") in favor of NEUTRON HOLDINGS, INC., a Delaware corporation (the "Grantor"). Capitalized terms used and not defined herein have the meanings given to such terms (whether directly or by reference to another agreement or document) in the PATENT SECURITY AGREEMENT (as defined below).

WHEREAS, the Grantor and BOM are parties to that certain (i) PATENT SECURITY AGREEMENT, dated as of March 13, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof; the "PATENT SECURITY AGREEMENT I"), (ii) PATENT SECURITY AGREEMENT, dated as of May 15, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof; the "PATENT SECURITY AGREEMENT II") (PATENT SECURITY AGREEMENT I and PATENT SECURITY AGREEMENT II collectively referred to herein as PATENT SECURITY AGREEMENT), (iii) CREDIT AGREEMENT, dated as of March 13, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof; the "CREDIT AGREEMENT"), and (iv) SECURITY AGREEMENT, dated as of March 13, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof; the "SECURITY AGREEMENT"), pursuant to which the Grantor granted to the Secured Party a security interest in all of such Grantor's right, title, and interest in, to, and under all patents and patent applications of such Grantor listed on Schedule I attached hereto ("Patent Collateral");

WHEREAS, the PATENT SECURITY AGREEMENT I was recorded with the United States Patent and Trademark Office ("USPTO") on March 27, 2020, at Reel/Frame 052248/0585, and PATENT SECURITY AGREEMENT II was recorded with the USPTO on May 15, 2020, at Reel/Frame 052675/0304 (both with respect to the Grantor Patent Collateral);

WHEREAS, pursuant to the Pay-Off Letter, dated June 4, 2021, between the Grantor and BOM, BOM terminated and released its security interest in the Patent Collateral; and

WHEREAS, BOM has agreed to execute and deliver this Release to evidence the release of its security interest in the Patent Collateral.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, BOM hereby terminates and releases the entirety of its security interest in the Patent Collateral, and hereby re-assigns, re-transfers and re-conveys to the Grantor any and all right, title, and interest BOM may have in, to, or under the Patent Collateral.

This Release is applicable solely with respect to the security interest granted in favor of BOM to the Patent Collateral.


BOM hereby authorizes and requests that the Commissioner for Patents and any other applicable government officer record this Release with the USPTO.
