## **NUNC PRO TUNC PATENT ASSIGNMENT**

**THIS NUNC PRO TUNC PATENT ASSIGNMENT** is made effective as of March 21, 2011 by IXYS CH GMBH, a company organized and existing under the laws of the Switzerland, with its principal place of business at Mattenstrasse 6, 2555 Brugg b. Biel BE Switzerland (hereinafter referred to as "ASSIGNOR") and UEI Cayman Inc., a company organized under the laws of the Cayman Islands ("ASSIGNEE").

**WHEREAS, ASSIGNOR**, in connection with that certain Agreement between the parties dated March 21, 2011 (the "Agreement"), assigned those inventions and applications identified by the U.S. patent and patent application numbers as listed on the attached Schedule A to ASSIGNEE in a Patent Assignment instrument dated March 21, 2011; and

**WHEREAS, ASSIGNOR and ASSIGNEE** have discovered certain errors in the March 21, 2011 Patent Assignment and as such, ASSIGNOR is executing this present Nunc Pro Tunc Patent Assignment which shall correct and replace Schedule A of the March 21, 2011 Patent Assignment in its entirety with the attached Amended Schedule A (hereafter "PROPERTIES");

**NOW, THEREFORE**, subject to the terms and conditions of the Agreement and other good and valuable consideration, the receipt of which is hereby acknowledged, the ASSIGNOR, has sold, assigned, transferred and set over (or caused to have been sold, assigned, transferred and set over), and by these presents does hereby sell, assign, transfer and set over (or hereby causes the sale, assignment, transfer and set over of), unto ASSIGNEE, its successors, legal representatives and assigns, ASSIGNOR's entire right, title and interest in, to and under the inventions, the applications, and the patent set forth on Amended Schedule A and all divisions, renewals, continuations, and continuations-in-part thereof, and all patents of the United States which may be granted thereon and all reissues and extensions thereof; and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may be filed for such inventions in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from said United States applications under the patent laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; and all forms of industrial property protection, including, without limitation, patents, utility models, inventors' certificates and designs which may be granted for such inventions in any country or countries foreign to the United States and all extensions, renewals and reissues thereof;

**AND ASSIGNOR HEREBY** authorizes and requests the Commissioner for Patents and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

**AND ASSIGNOR HEREBY** represents and warrants that it has full right to convey the entire interest herein assigned, and that it has not executed any agreement in conflict herewith.

**AND ASSIGNOR HEREBY** further covenants and agrees that it will not execute any agreement in conflict herewith and that, upon ASSIGNEE'S written request and at ASSIGNEE's sole expense, it will (i) communicate to the ASSIGNEE, its successors, legal representatives and assigns, any facts known to it respecting the aforementioned inventions and (ii) provide reasonable assistance to ASSIGNEE, such as by testifying in any legal proceeding, signing all lawful papers, executing all divisional, continuing, reissue and foreign applications included within the PROPERTIES, making all rightful oaths, and generally doing everything reasonably necessary to aid the ASSIGNEE, its successors, legal representatives and assigns, in obtaining and enforcing proper protection for said inventions in all countries (subject to Section II of Schedule A).

**IN TESTIMONY WHEREOF**, the person executing this Assignment in a representative capacity on behalf of the ASSIGNOR warrants that he/she is fully authorized and empowered to do so and sets his/her hand and seal the day and year set with his/her signature.
