In pursuance of the LOI and in consideration of the sum of £1 now paid by the Assignee to the Assignor (receipt of which the Assignor hereby acknowledges), the Assignor hereby assigns, releases and conveys to the Assignee with full title guarantee the Patents, the Applications and the Invention, and the full and exclusive benefit thereof, the right, title and interest therein, and all the rights, powers, privileges and immunities conferred on the applicant thereof by the filing of the Patents and the Applications free from all incumbrances and including the right to be granted a patent from the Applications or any new application or applications in respect of any part or parts of the subject matter of the Applications, the right to claim priority from the Applications and to sue for damages and other remedies in respect of any infringement of the Patents or any Patent(s) resulting from the Applications.




