Transfer of Assets and Liabilities

This agreement (the “**Agreement**”) is hereby concluded by and between

(a) Kelicomp AB, org.no. 556904—9702 (“**Kelicomp**” or the “**Seller**”), with the address P.O. Box 14 007, 167 14 Bromma;

and

(b) URAEUS Communications Systems AB, org.no. 556778-2270 (“**URAEUS**” or the “**Buyer**”), with the address Rånäs Bruksväg 68, 762 96 Rånäs,

below also jointly referred to as the “**Parties**” and individually as “**Party**”.

Agreement

1. As of the Completion Date, as defined in point 3, Kelicomp transfers all of its assets listed in Appendix 1 to URAEUS. The transfer is to be exempted from VAT pursuant to Chapter 2, Section 1b of the Swedish Value Added Tax Act (ML). Should the transfer not be approved as being exempted from VAT, URAEUS is to remunerate Kelicomp in an amount corresponding to 25 % VAT on the purchase price (as defined in point 2).
2. The purchase price of SEK 100,000 is to be paid in cash. The purchase price is to be paid to the bank account specified by the Seller on the date of the signing of the agreement.

Completion Date

3. The agreement is considered completed on the date when this agreement has been signed and exchanged between the Parties, and when the purchase price has been paid to the Seller in full (the “**Completion Date**”).
4. On the Completion Date, the Seller is to transfer all property covered by this agreement to the Buyer. Following this date, the Seller will not have any rights to the property encompassed by this agreement or of any other rights attached to these.
5. On the Completion Date, the Seller will be transferring the so-called Terra computer, which has been used for purposes of development work.

Commitments Regarding the Property

6. The Seller guarantees that the Seller owns the transferred property, and that it is free of any restrictions related to title retention or any other encumbrances, and warrants that the property is not a pledged asset or the subject of foreclosure as of the Completion Date.

7. The Buyer is responsible for ensuring that the transferred property is re-registered to the Buyer in accordance with proper procedure, where this is required.

Name and Other Intellectual Property Rights

8. The Seller transfers all patents and intellectual property rights pertaining to the business or its operations.
9. The agreement does not include the name of the Seller (legal name).

Additional Terms

10. This agreement does not include the debts of the Seller.
11. This agreement does not include the staff of the Seller.
12. The Seller commits to transferring all necessary documents, permissions, etc. regarding all property that is encompassed by this Agreement on the completion date.

Applicable Law and Conflict Resolution

The Agreement is subject to Swedish law. Final decisions in conflicts arising from the Agreement are to be made by general court, with the Stockholm District Court (Stockholm tingsrätt) as the first instance.

This agreement has been drawn up in two identical copies, with each of the parties receiving one such copy.


