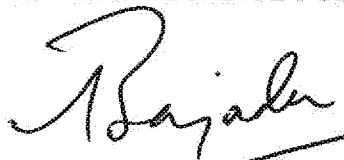
"**FIRST:** The name of the corporation is OutSmart Technologies, Inc. (the "**Corporation**")."
