Assignors authorize and request the Commissioner for Patents to record Assignee as the owner of the Patent Application, including any continuations, divisions, continuations-in-part, reissues, reexaminations or extensions thereof, and to issue any and all letters patents of the United States thereon to Assignee, as assignee of the entire right, title and interest in and to the same, for the sole use and enjoyment of Assignee, its heirs, successors, assigns or other legal representatives.




